

PERMANENT SEAT LICENSE TRANSFER

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned Licensee(s) (whether singular or plural, "Transferor") of the Permanent Seat License Agreement(s) identified below (by section, row and seat of the associated seating) for Chicago Bears Home Football Games at the New Soldier Field (whether singular or plural, "PSLs"), does hereby transfer, sell and assign ("Transfer") all right, title and interest of Transferor in and to the PSLs to the transferee named below ("Transferee"), and the Transferor does hereby authorize and direct The Chicago Bears Football Club, Inc. (the "Team") to effect this Transfer of the PSLs and of the season ticket purchase rights associated therewith to Transferee.

Transferor represents and warrants to Transferee, the Team and the Chicago Park District (the "District") that Transferor has full authority, power and right to Transfer the PSLs free and clear of any interest or right of any other parties (except for the rights of other parties expressly set forth in the PSLs). Transferor further represents and warrants to the Team and the District that Transferor has performed all its obligations as Licensee under the PSLs, and that this Transfer is being made in compliance with the Permanent Seat License Agreement Terms and Conditions (the "Terms and Conditions") set forth as Exhibit B to the PSLs, such Exhibit B being attached hereto and incorporated herein by reference. Transferor shall indemnify and hold harmless the Team, Transferee and the District from any claim, loss or expense arising out of any claimed breach or violation of such representations and warranties. Transferor furthermore (i) confirms that Transferor is not paying any monies or consideration to the District in connection with this Transfer, and (ii) waives all claims against the District with respect to the PSLs being transferred and the Transfer thereof.

This Transfer shall be effective upon receipt by the Team of this document fully completed and signed by the Transferor and the Transferee, and when the Transfer is recorded in the PSL ownership records maintained by the Team. Upon becoming effective, this Transfer shall entitle the Transferee to all rights pertaining to the PSLs commencing with the sale of season tickets for the next ensuing Chicago Bears football season.

The Transferee furthermore (i) confirms that the Transferee is not paying any monies or consideration to the District in connection with this Transfer, and (ii) waives all claims against the District with respect to the Transfer.
