



CHARTER SEAT TRANSFER POLICIES and FORM

POLICIES

- Transfers may only be completed if Charter Seat License has been paid in full for one year
- Transfers may only be submitted between January 15 and June 15 of each year
- Unless waived, the transferor must submit a transfer fee of \$150 per new transferee account (not per ticket)
- Signatures and proper additional documentation are required for transfers
- Transfers are subject to transferee signing new Charter Seat License Agreement
- A Charter Seat License may only be transferred once per year
- Procedures and transfer fees are subject to change without notice

TRANSFEROR REQUIREMENTS

- A. Payment of transfer fee must be in the form of cash, money order or cashier's check made payable to the Seattle Seahawks. Visa, Mastercard, American Express and Discover cards also will be accepted.
- B. Transfer form must include: account number, individual or company name, current address and phone numbers of transferor and transferee, and seat locations to be transferred.
- C. An individual transferor must sign the transfer form.
- D. Transfer fee may be waived if transfer is made to an immediate family member. Proof of relationship is required.
- E. A sole proprietorship or partnership account must attach an authorization using business letterhead signed by an officer or partner.
- F. A corporate account must furnish a corporate resolution authorizing the transfer signed by an officer.
- G. Executors of an estate of a deceased account holder must provide Letters Testamentary and must sign the transfer form (transfer fees will be waived).
- H. A divorce decree showing first page, page showing charter seat recipient and signature page must be submitted (transfer fees will be waived).
